SUBJECT: ACCEPTANCE REVIEW FOR BELLEFONTE NUCLEAR PLANT

In a letter dated March 22, 1978, we advised you that we were having difficulty making a determination as to the acceptability of the application for operating licenses for the Bellefonte Nuclear Plant, Unit Nos. 1 and 2. We pointed out that our inability to complete the determination was due primarily to the use in the Bellefonte units of a reactor protection system, RPS-II, of a design for which the schedule for the submittal of information needed by the staff for its review was not clear.

We met with members of your staff on May 10, 1978 to discuss the status of our review of Babcock & Wilcox, Inc. (B&W) Topical Reports which address the RPS-II design and operation. In that meeting, we stated that while our evaluation of B&W Topical Report 10121 was continuing, our review of B&W Topical Report 10085 could not be continued in a meaningful manner until certain software information is received. We understand that information will not be provided until October 1978.

On May 16, 1978, we met with TVA management representatives and based on a clarification of the status of the RPS-II information to be supplied it was concluded that we could proceed to docket your application. We stated that we will inform you late this year as to the staff's review schedule for the Bellefonte application and that the review schedule will address both the safety and environmental reviews.



Accordingly, your filing of the application should include three (3) originals signed under oath or affirmation by a duly authorized officer of your organization. In addition, your filing should include fifteen (15) copies of that portion of the application containing the general information and forty (40) copies of the Final Safety Analysis Report and forty one (41) copies of the Environmental Report. As required by Section 50.30 of 10 CFR Part 50, you should retain an additional ten (10) copies of the general information, thirty (30) copies of the Final Safety Analysis Report and one hundred and nine (109) copies of the Environmental Report for direct distribution in accordance with the Enclosure's to this letter and further instructions which might be provided later. Within 10 days after docketing, you must provide an affidavit that distribution has been made in accordance with these Enclosures. All subsequent amendments to the Final Safety Analysis Report will require sixty (60) copies for distribution. Amendments to the Environmental Report will require forty one (41) copies for distribution.

Should you have any questions concerning this matter, we will be pleased to discuss them with you.
