Ray - I have reviewed the draft notice of availability of environmental assessment and finding of no significant impact for license amendment to source materials license no. SMB-141, for unrestricted release of a portion of the Department of the Army, US Army Research, Development and Engineering Command, Army Research Laboratory facility at Aberdeen Proving Ground, Maryland that you forwarded. I have no technical objections to the proposed release of the Building 1103A area for unrestricted use.

There is an error in the "Agencies and Persons Consulted" section of the draft notice. The Notice should refer to the "Land Management Administration" rather than the "Hazardous Waste Administration". The notice should be changed to read as follows: "NRC provided a draft of this Environmental Assessment to the Maryland Department of the Environment (MDE), Air and Radiation Management Administration and Land Management Administration for review on XXXXXX. "
