IMC1252 Appendix B (Construction Inspector General Proficiency-Level Training and Qualification Journal) has been revised to clarify general qualifications, update activities and references, and add ISA-General-13, "Fuel Cycle Process Fundamentals."

IMC 1252 Appendix C (Construction Inspector Post Qualification Requirements, Continuing and Refresher Training) has been revised to add clarification to post qualification requirements and activities.

IMC 2507 (Construction Inspection Program: Vendor Inspections) has been revised to provide guidance for translators and/or interpreters when necessary.
