In response to your letter dated February 9, 2011 I offer the following additional information:

1. Shieldalloy is requesting a change of Trustee in regards to the existing Standby Trust Agreement entered into as of July 19, 1990. We are not requesting any additional changes, amendments, or deletions at this time. As per Section 13 of the original Trust Agreement, SMC is requesting that the Trust in question be transferred from the current Trustee, JPMorgan Chase Bank, N.A. to our preferred Trustee, RBS Citizens N.A.
2. In a prior correspondence dated May 27, 2010, SMC incorrectly referred to the successor Trustee as "Citizens Bank, N.A., Wealth Management & Institutional Services". The correct name for the desired successor Trustee is "RBS Citizens, N.A."
