Progress Energy Florida, Inc. (PEF) hereby submits this copy of the Physical Security Plan (Revision 3) for the Levy Nuclear Plant as Enclosure 2 to this letter. This revision incorporates, in part, changes resulting from NRC review of Revision 2 of the Plan. It is requested that this revision to the Levy Nuclear Plant Physical Security Plan (Revision 3) be reviewed with the Levy Nuclear Plant combined license application in accordance with 10 CFR 52.79(a)(35), in lieu of Revision 2 of the Physical Security Plan submitted September 9, 2009. Enclosure 1 contains variances to the generic text of NEI 03-12 Revision 6, Template for the Security Plan, Training and Qualification Plan and Safeguards Contingency Plan.

Enclosures 1 and 2 contain Safeguards Information (SGI) as defined by 10 CFR 73.2 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, Enclosures 1 and 2 should be withheld from public disclosure in accordance with 10 CFR 73.21 and 10 CFR 2.390(a)(3).
