Dear Mr. Garner:

Attached is our answer to question 21 of your letter of April 5, 1974 which reads as follows:

"21. (p 5-1, p 5.1.1). A nuclear power station at the Bellefonte site does not appear to violate any overall land-use plan for this area of whom? Who has long designated the water front near Scottsboro for industrial use? When did this take place? When did Alabama industrial development agencies concur in this designation? When did the Top of Alabama Regional Council of Governments propose the plan for future land use? When did the Top of Alabama Regional Council of Governments develop a program for the Hollywood environs which propose an industrial area on both sides of the railroad to the station? Explain in detail, insofar as land usage is concerned, why the impact of the operation of the Bellefonte plant upon its immediate environs will be acceptable. Attach to the answer to these interrogatories copies of studies, minutes, reports and correspondence relative to this interrogatory."

Included are the names of six publications we have reviewed in our consideration of the contention involving the location of the access railroad spur. We have shown where those publications can be obtained.

Also attached is a report entitled "Trip Report on Site Visit to Bellefonte Nuclear Plant, Units 1 and 2, Scottsboro, Alabama".

ANSWER TO QUESTION 21 IN LETTER OF APRIL 5, 1974

The statement on page 5-1 of the Staff's Draft Environmental Statement that a nuclear power station at the Bellefonte site does not appear to violate any overall Iand-use plan was based on the Staff's review of land-use planning studies prepared by (1) TARCOG for Hollywood and Jackson County and (2) the Scottsboro City Planning Commission for the Town of Scottsboro. A listing of these reports and the locations where they can be obtained are set out below. In addition to these published reports, the Staff also met with members of TARCOG and the townleaders of Scottsboro and Hollywood to discuss, among other things, land-use. From these discussions, the Staff found no inconsistencies with the development of the Bellefonte site for a nuclear power plant and long-range, land-use plans for the Hollywood area.

Concerning the waterfront land near Scottsboro, the TVA has stated on page 2.9-9 of their Draft Environmental Statement, dated March 6, 1973, that "TVA has long designated the land for eventual industrial use and this has also been the judgment of Alabama industrial development agencies." The Staff does not know the date that the Alabama industrial development agencies concurred in this designation.

In 1972, the Town of Hollywood contracted the services of TARCOG to prepare a Sketch Development Plan, Zoning Ordinance, and Subdivision Regulations. The Sketch Development Plan was completed by TARCOG in March 1973, while the latter two reports were completed in May 1973. The sketch plan, zoning ordinance, and subdivision regulations proposed by TARCOG in these reports were adopted by the Town Council and the Planning Commission for the Town of Hollywood in May 1973.

The Staff's conclusion that the impact of the operation of the Bellefonte plant upon its immediate environs will be acceptable relative to land-usage is based on the above-mentioned reports by TARCOG and the Scottsboro City Planning Commission and discussions with representatives of TARCOG, Hollywood, and Scottsboro.

TRIP REPORT ON SITE VISIT TO BELLEFONTE NUCLEAR PLANT, UNITS 1 AND 2, SCOTTSBORO, ALABAMA

During the week of August 20, 1973, the ANL team and representatives of ESB, CEAB, and EP-4 accompanied me on a visit to the site of the TVA proposed Bellafonto Huclear Plant. This visit was preceeded by meetings with several local officials in the towas of Scottsboro and Hollywood and was followed by technical discussions with TVA and a visit to several state offices in Montgomery, Alabama.

A list of the participants, the various people and offices contacted and an itinerary are attached.

The first meeting was with the "Top of Alabama Regional Council of Governments (TARCOG)" organization. This organization represents the Alabama Development Office (AEO) and is involved on a local level with the five northern counties in Alabama - DeKalb, Jackson, Limestone, Madison and Marshall. TARCOG has proposed and the city of Mollywood has adopted comprehensive plans for land use, community facilities, thoroughfares and capital improvements is preparation for the construction of the Bellefonte Muclear Plant nearby. The plan has been submitted to HUD via ADO (which acts as the clearinghouse) for funding. implementation, however, funds are not available at present.

Visits and discussions with the local officials in the towns of Hollywood and Scottsboro were of benefit since the socioeconomic impact of plant construction and operation would be born primarily by these two towns. TVA can help mitigate some of the impact but exactly how is not clear at present since its plans are not too well formulated.

A visit to the proposed Bellefonte site was partially marred by the fact that the AEC team did not set foot on the site itself, due to a last minute objection by the fee titleholder whose land was in limited possession of TVA by virtue of a condemnation court order but subject to the outcome of a pending lawsuit arguing TVA's right to build power plants. The site visit was quite valuable to the team, however, because of other viewing capabilities that had been arranged for prior to the above circumstance. A fixed wing aircraft was used to view the site and surrounding areas at a considerable distance from the site including tog of three alternate site locations. Helicopters were used for a

closer inspection of the site; the proposed transmission line routing and the more immediate surrounding environs. The helicopters were also used to examine receasely constructed and existing 151 and 500 KV transmission line rights-of-way to gain an insight into TVA's general construction and helicopter dispersed herbicide maintenance techniques. Finally, a boat was utilized for examining three sides of the peninsula on which the plant would be situated as well as the location of certain plant/site specifics such as the proposed intake at the end of an 800 foot embayment, the blowdown discharge, the access causeway across Town Creek and the temporary construction dock. The AEC/ANL participants were dispersed among the various vehicles so no one individual utilized all three modes.

The afternoon and early evaning of the second day and all of the third day was spent in discussing TVA's responses to the site agenda questions. Some of the subject material was covered by small groups outside the main meeting where the bulk of the discussion took place.

As a result of these discussions, a list of questions based on the site agenda questions will be transmitted to TVA by September 14, 1973, for a docketed response in the form of a second supplement to its draft statement.

The last day was spent visiting with various state officials in Montgomery, Alabama, and some significant information was obtained.

<u>Mater Improvement Commission</u> - Indicated that Alabama had EPA approved stream standards for the Tennessee River Basin (TRB). The state does not have permitting capability at present and does not want it until they have sufficient staff to do "proper" enforcement. This may take in excess of two years to accomplish. This office also provided us with the current water quality classification for the TRB and the corresponding water quality criteria.

Conservation and Natural Resources - Division of Game and Fish This group is very much involved in the Bellefonte area since they manage two nearby wildlife rafuges. They are concerned with the impact on wildlife and fish of the proposed nuclear plant. They recommended that the Town Creek embayment not be developed for recreational purposes but allowed to remain in the natural state. This is in direct contradiction to TVA's proposal to develop the embayment.

Historical Commission - This group felt that the old town of Sellefonce contains a lot of local history and should be considered an historical site. They also suggested cestoring some of the Bellefonte buildings and perhaps moving them to the proposed visitor center. Department of Finance and Revenue - From our visit to these offices we determined that TVA makes payments in lieu of taxes to the state of Alabama which incorporates these payments into the general fund and does not redistribute them to the local areas.

Development Commission - Essentially acts as the state clearinghouse. However, mone of the above organizations (or the others that were visited) had received their own copies of TVA's draft statement. In view of this, copies of the AEC DES will be sent directly to the above offices as well as to the clearinghouse.
