I have been informed that you have filed a request to intervene in the public hearings to be held in connection with the application of the Tennessee Valley Authority for a license to construct the Bellefonte Nuclear Plant, Units 1 and 2.

It is our policy to meet with members of the public who may have concerns regarding the proposed construction or operation of nuclear power plants to elicit information as to the nature of the concerns, such that the radiological safety and environmental impact reviews conducted by the Regulatory staff can be responsive to these concerns. Such meetings also provide an opportunity for staff members to discuss the licensing process and to answer questions regarding the proposed facility.
