As discussed with you, we have also included the schedule for submittal of information for the Watts Bar plant. The supplemental information includes both thermal and nonthermal data, as necessary, to complete the NPDES permits. Our present schedules are:

Watts Bar Nuclear Plant - February 21, 1978 Sequoyah Nuclear Plant - March 15, 1978 Bellefonte Nuclear Plant - May 1, 1978 Martsville Nuclear Plant - July 1, 1978

We will include with the additional information for the Sequoyah plant a detailed description of a proposed mixing zone.
