This letter is in reply to Generic Letter 81-21 concerning natural circulation cooldown at Bellefonte Nuclear Plant. Items 2.1 and 2.2 of the generic letter were responded to in a letter from L. M. Mills, TVA, to E. G. Adensam, NRC, on February 3, 1984.

Item 2.3 of the generic letter requests a description of the cooldown procedures and the training program to implement them. The Procedures Generation Package (PGP) with integral part Abnormal Transient Operating Guidelines (ATOG), Part II, Volume I, contains a description of both the cooldown procedures and the training program. Therefore, the answer to Item 2.3 of Generic Letter 81-21 is contained in the PGP with integral part ATOG, Part II, Volume I. The PGP was submitted in a letter from J. A.
