SUBJECT: LEVY NUCLEAR POWER PLANT, UNITS 1 AND 2 COMBINED
LICENSE APPLICATION – ADVANCED SAFETY EVALUATION
WITHOUT OPEN ITEMS FOR CHAPTER 13, “CONDUCT OF
OPERATIONS”

By letter dated July 28, 2008 (ML082260277), Progress Energy Florida, Inc. (PEF) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) for a combined license (COL) for Levy Nuclear Power Plant (LNP), Units 1 and 2.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Advanced Safety Evaluation (ASE), without open items for Chapter 13, “Conduct of Operations” (ML110320002). Unless otherwise stated in the ASE, the staff’s review was based on Revision 2 of the application. The ASE is being provided to support a meeting of the subcommittee of the ACRS in October 2011. The ACRS full committee meeting will be held after the subcommittee meeting.

For Chapter 13, the staff plans on focusing their presentation on the following specific categories of interest:

- Section 13.3, “Emergency Planning”
 - The centralized (shared) Emergency Operations Facility (EOF) with Crystal River Unit 3 (CR3)
