Explanatory notes regarding the Emergency Plan and Supplemental Information

The Shearon Harris Nuclear Power Plant Units 1, 2, and 3 Combined License Emergency Plan consists of a full and integrated plan, six appendices, and two annexes. The plan is written in accordance with NUREG-0654 and provides detailed information regarding each of the sixteen Planning Standards and associated Evaluation Criteria. The six appendices that follow provide additional detailed information on various aspects of the Emergency Plan. The two annexes allow for unit specific information, specifically, Annex 1 applies to the existing Unit 1 at Shearon Harris, and Annex 2 applies to the new Units 2 and 3. Supplemental information includes the detailed February 2009 evacuation time estimate report as concurred with by the State of North Carolina, and Counties of Chatham, Harnett, Lee and Wake, an implementation schedule for the integration of the existing plan and the combined license plan, a regulatory compliance cross-reference, an impact evaluation performed under 50.54.q, emergency action guidelines for unit 1, an emergency action level basis document for the new units, and state and local emergency planning documents. The following table delineates documents included as the Emergency Plan and those documents found in Supplemental Information. Emergency Planning Inspections, Test, Analyses, and Acceptance Criteria (ITAAC) are included in Part 10 of the COLA.
