

This letter is in response to your letter of April 22, 1977, to Godwin Williams, Jr., requesting adoption of a standardized format for recording meteorological data. TVA has reviewed the format enclosed in the letter and will begin utilizing it for recording data from the meteorological stations at our nuclear plants. The first application of the new format for licensing will be the Bellefonte Final Safety Analysis Report (FSAR) which is scheduled for submittal on December 1, 1977. The FSAR's for Hartsville, Phipps Bend, and Yellow Creek will utilize this new format, however, we do not plan to revise the format in any of the SAR's now under review. This approach has been discussed with William Snell, NRC, and we believe it to be compatible with the requests in the April 22, 1977, letter.
