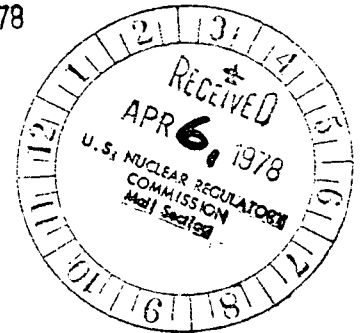

Dear Mr. Denton:

We have reviewed the Tennessee Valley Authority's report on submerged multiport diffuser design for Bellefonte Nuclear Plant, Units 1 and 2, [50-438 and 439], Jackson County, Alabama, and have the following comment.

We concur with selection of the recommended diffuser design as being the best for meeting the dilution objectives. The environmental effects are not expected to be significant.

We note that an interrelated Federal action associated with this project will be the need to secure a National Pollutant Discharge Elimination System (NPDES) permit from the Environmental Protection Agency. Based on available information at this time, the Fish and Wildlife Service expects that it would have no objection to issuance of a NPDES permit unless there is a significant change in the recommended diffuser design.

We appreciate the opportunity to review this report.
