2) Physical Description

This shipment will consist of 8 x 30B cylinders in sealed overpacks containing 12,320 kgs Uranium Hexafluoride (UF6), enriched to less than 5% weight of U-235.

3) Transportation and Route Schedule

The ocean transportation from Liverpool, England to Halifax, NS will be the responsibility of Atlantic Container Line. The inland transportation from Halifax, NS to Westinghouse/Columbia, SC by road will be the responsibility of RSB LOGISTIC SERVICES, INC.
