2) Physical Description

This shipment will consist of 8 x 30B heeled cylinders in sealed overpacks on 2 x 20' flatracks containing 54.08 kgs of Uranium, RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, FISSILE (HEELS) and 8 x 30B empty, cleaned and washed cylinders in protective overpacks on 2 x 20' flatracks, RADIOACTIVE MATERIAL, EXCEPTED PACKAGE, EMPTY PACKAGES.

3) Transportation and Route Schedule

The surface transportation from Richland, WA to Baltimore, MD will be the responsibility of RSB LOGISTIC SERVICES INC. The ocean transportation from Baltimore, MD to Hamburg, Germany will be the responsibility of Atlantic Container Line.
