What we've decided to do at this point is move forward with our Phase 1 review in geology. The supplement didn't cover everything we needed it to, but we think the most effective way will be to go ahead with the site audit in late Feb, and it's possible we may need a second audit just for geology later. Because it took so long to get the supplement, the schedule doesn't work anymore for 2.5.1 and 2.5.3. We could support a date of 4/24, which I think should be OK with you guys, because it's the same as the geotech Phase 1 dates. If OK, please get this changed in EPM. Thanks!
