UniStar's letter **ML102780317** provides response to Question 17.5-6 of your RAI No. 200 (eRAI 4128). The letter also provides the revised QAPD (UN-TR-06-001-A, Quality Assurance Program Description, Revision 2).

The applicant has stated that the report does not include revision bars to indicate the changes because it is a complete rewrite. However, a summary of alterations is provided in Enclosure 1 of the letter.

I also want to draw your attention to the following statement in the UniStar letter:

“The revised QAPD includes an alternative for a commitment to Regulatory Guide 1.33, consistent with the guidance provided in NEI 06-14, accepted by the NRC in the Final Safety Evaluation for Technical Report NEI 06-14, "Quality Assurance Program Description," Revision 9, dated July 13, 2010. Consistent with the safety evaluation, the QAPD is being provided to the NRC for review. In accordance with the provisions of 10 CFR 50.54(a)(4)(iv), the changes to the QAPD will be considered accepted by the Commission upon receipt of a letter to this effect from the Commission or 60 days after submittal to the Commission, whichever occurs first.”

Please review the response to the RAI and appropriately update the status of the applicable questions in the eRAI system. In addition, please review the revised QAPD provided as enclosure to the letter. If the contents of the revised TR are not acceptable, please let the projects branch know prior to **60 days from the submission date** so that the applicant can be informed accordingly.
