In accordance with Inspection Manual Chapter 0320, "Operating Reactor Security Assessment Program", a security annual assessment meeting was conducted at the James A. FitzPatrick Nuclear Power Plant, Scriba, New York, between the Nuclear Regulatory Commission (NRC) and Entergy Nuclear Operations, Inc. on May 5, 2011, at 7:30 a.m. The NRC presented and discussed its assessment of the security performance of the Fitzpatrick Nuclear Power Plant for the period between January 1 through December 31, 2010.
