
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)  
 The purpose of this modification is to provide incremental funding in the amount of \$110,000.00 thereby increasing the total obligations from \$674,179.00 to \$784,179.00. Accordingly the contract is modified as follows:

Refer to Section A.2 entitled "Consideration and Obligation - Labor Hours", paragraph (b) first sentence is deleted in its entirety and replaced with the following:

" (b) The amount presently obligated with respect to this contract is \$784,179.00"

All other terms and conditions remain the same including the contract ceiling of \$859,135.98.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
