Bob and Jason,

First of all, thank you very much for your quick reviews of Rev. 7 of the CCNPP3 FSAR and bringing to my attention the missing sections.

(For those, who may not be aware of what I am talking about, Bob Radlinski in his email of January 10, 2011 pointed out to me that UniStar, for some reason, had taken out section 9.5.4.4 of the CC3 FSAR, Revision 7.

In his email of January 4, 2011, Jason Dreisbach brought to my attention that CCNPP3 FSAR missed to include Section 19.2.7, pertaining to the Aircraft Impact, which was added by AREVA in Revision 2 of their FSAR. Also this addition was not included in their list of commitments for Revision 8)

Based on the above information, I checked with the applicant if their revision of the FSAR should have included these two sections. The result of my discussions with UniStar is their letter UN#11-008, dated January 14, 2011 (ADAMS Accession Number **ML110190086**), which provides supplemental information which includes FSAR markups for the two missing sections. The following Enclosures to this UniStar letter provide the FSAR markups, which will be included in the next revision of the COLA.
