QUESTIONS for Integrated Security Coordination and Policy Branch (NSIR/DSP/ISCPB)

13.07-1

Under 10 CFR 52.79(a)(44), the Applicant's FSAR must contain a description of the fitness for duty (FFD) program required by 10 CFR Part 26 and its implementation. Describe how the COL Application, FSAR, Part 2, Table 13.4-1, item 15, comports with 10 CFR 26, Sections 26.3 and 26.4, and guidance in NRC's letter to the Nuclear Energy Institute dated December 2, 2009, entitled "Status of U.S. Nuclear Regulatory Commission Review and Endorsement of NEI 06-06, 'Fitness for Duty Program Guidance for New Nuclear Power Plant Construction Sites.'" Provide site-specific information to clearly and sufficiently describe your FFD program in terms of scope and level of detail to allow a finding of reasonable assurance of acceptability.

Under 10 CFR 52.79(a)(44), the Applicant's FSAR must contain a description of the fitness for duty (FFD) program required by 10 CFR Part 26 and its implementation. In the COL Application, Part 7-1.2.5, Departures and Exemption Requests, you state that PPL Bell Bend, LLC requires a schedule exemption from the requirement in 10 CFR 52.79(a)(44) to provide a description of the FFD program and its implementation. You state that the description will be provided at a later date and that "this additional time will allow BBNPP to prepare a FFD program that takes advantage of industry experience regarding the implementation of a workable FFD program based on the recently promulgated 10 CFR 26 regulations." Considering the date of the promulgation to which you refer is March 31, 2008, do you still intend to request this exemption?

Under 10 CFR 52.79(a)(44), the Applicant's FSAR must contain a description of the fitness for duty (FFD) program required by 10 CFR Part 26 and its implementation. Describe why the licensee is proposing license conditions for FFD when Part 26 provides explicit implementation requirements.
