To satisfy the requirements of 10 CFR 52.79(a)(1)(iii), 10 CFR 100.20(c), 10 CFR 100.21(d), and GDC 2, additional information is required regarding maximum post-construction groundwater elevations in areas near the SSCs. In a March 15, 2011 letter to NRC, the applicant provided a response to RAI 02.04.12-25 regarding the groundwater elevation estimation. In order to complete confirmatory analyses related to this RAI response, the NRC requests that the applicant provide the MODFLOW input files used in the evaluation of maximum post-construction groundwater elevations in the areas between SSCs and the surrounding storm water drainage ditches.
