Dear NRC, VDEQ & Office of Environmental Impact (Coastal Zone)

I am concerned with the potential for many environmental and safety issues for the proposed third reactor at Lake Anna. I support the need for nuclear energy in the vast array of electrical generation capabilities for the United States.

In light of the Japanese disaster with about 4 nuclear facilities in a melt-down, it is imperative that all permits, environmental studies, and Coastal Zone Consistency Certifications come to a complete stop, until the U.S can completely evaluate the Japanese outcome and develop lessons learned. The lessons learned must then be incorporated into all future environmental studies, water permits and Consistency Certifications, so they will insure the health, safety and welfare of all the 3 million annual users and residents of Lake Anna.

I also feel that making ANY final Environmental Review, Water Permits or Coastal Zone decisions that have to deal with the third reactor, BEFORE THE REACTOR DESIGN HAS EVEN BEEN DECIDED and will not be finalized until 2013 may well be a basis for future unnecessary lawsuits and definitely is not in the public's best interest.

I have read all of the email submittals from the Friends of Lake Anna and agree 100% with and endorse all of their concerns and will not repeat all of them here for the sake of brevity.

I further request that the Coastal Zone Consistency Certification review issue an OBJECTION to Dominion's request for a Consistency Certification. Once the Japanese scenario and all of the Friends of Lake Anna concerns are addressed in a responsible manner, not a political aspect, I will reconsider.
