Global Nuclear Fuel-Americas hereby submit a Standard Practice Procedures Plan (SPPP) for Energy Engineering Resources Inc., 1932 Arapahoe Basin Ct, Wildwood, MO, 63011 location, doing business at 1093 Commerce Park Dr., Suite 300, Oak Ridge, TN 37830, to the U.S. Nuclear Regulatory Commission (NRC) and request the issuance of an NRC Non-Possessing facility security clearance for this facility. This request has been previously discussed with Mr. J. Keith Everly. The SF-328 and List of Owners, Officers, Directors, and Executive Personnel (OODEPs) forms/information for Energy Engineering Resources have not changed since the last submission for FOCI.

To support project schedules, we request that NRC reviews and approvals be accomplished to support issuance of a facility clearance for this facility by June 10, 2011. To support this schedule, we request any initial NRC comments or questions regarding the SPPP by May 23, 2011, and an NRC readiness review for the Energy Engineering Resources Inc. facility on or before June 10, 2011. We will work with NRC staff to establish the actual review date.
