Dear Mr. Lutchenkov:

I am writing with regard to the Maryland Department of the Environment ("MDE" or "Department") letter dated April 26, 2011, in response to Unistar Operating Services, LLC (Unistar) request that the decision date for MDE's decision(s) on the referenced project be extended until the release of the Final Environmental Impact Statement (FEIS) by the Nuclear Regulatory Commission. This letter supercedes MDE's April 26, 2011 response to Unistar's request. Inadvertently, due to my oversight, the Department's letter did not reference MDE's report and recommendation to the Board of Public Works (BPW) on the Tidal Wetlands License required for the project.


As noted in MDE's April 26, 2011 letter, the State's nontidal wetlands regulations allow the Department to extend the decision date for up to six months at the request of the applicant. Further, State statute allows the Department to extend the decision date on an application for a Tidal Wetlands License due to "extenuating circumstances" [Md. Code Ann., Envir. § 5-204(b)(4)].

Accordingly, the Department hereby extends extends the decision date on the Nontidal Wetlands and Waterways application and the report and recommendation to the BPW until October 21, 2011, or until within approximately 30 days of the release of the FEIS, whichever comes first. As noted in the Department's April 26, 2011 letter, these decisions will be coordinated with that of the U.S. Army Corps of Engineers on the project.
