To Whom It May Concern:

We are writing to request an amendment to our DuPont Wilmington, Delaware area radioactive material licenses to make the following changes:

- Change the name of our Radiation Safety Officer from Michael B. Ohm to John M. Brisbin.

Mr. Ohm has recently accepted a position at another DuPont facility in New Jersey effective July 1, 2011.

This change in Radiation Safety Officers is requested for the following DuPont radioactive material licenses.

- License No. 07-00455-02 (DuPont Experimental Station, Wilmington, DE)
- License No. 07-00455-41 (DuPont Experimental Station, Wilmington, DE)
- License No. 07-00455-27 (DuPont Chestnut Run Plaza, Wilmington, DE)
- License No. 07-13441-02 (DuPont Stine-Haskell Research Center, Newark, DE)

Fifty percent of Mr. Brisbin's time has been allocated to overseeing the Radiation Program at these sites. Mr. Brisbin is a member of our Safety, Health, and Environment Organization. He has a B.S. in Natural Sciences from the University of Pittsburgh, and is pursuing his M.S. in Public Health & Environmental Safety at West Chester University. Mr. Brisbin has attended a forty-hour Radiation Safety Officer Course (Dade Moeller Radiation Safety Academy; Gaithersburg, MD; 2010), has been an active member of the Experimental Station and Stine-Haskell Research Center Radiation Safety Committees, and has been serving as the Assistant RSO since 2010. Mr. Brisbin has over ten years of experience in the use of radioactive materials.

As part of our succession planning, Mr. Brisbin has worked with Mr. Ohm over the past year on the following areas as they relate to the management and oversight of our radiation safety programs.

- Conduct of semi-annual audits of radioactive material use, storage, and waste areas
- Leak testing of sealed sources

- Commissioning and decommissioning of radioactive material use, storage, and waste areas
- Participation in annual Radiation Safety Committee reviews of the radiation safety program

- Radioactive material ordering and delivery processes
- Radioactive waste processes
- Orientation and refresher training programs
- Dosimetry program
- X-ray program
