§20.1201	Occupational Dose Limits for Adults	340.210(c)	A	<p>In § 20.1201, paragraph (c) is revised to read as follows:</p> <p>(c) When the external exposure is determined by measurement with an external personal monitoring device, the deep-dose equivalent must be used in place of the effective dose equivalent, unless the effective dose equivalent is determined by a dosimetry method approved by the NRC. The assigned deep-dose equivalent must be for the part of the body receiving the highest exposure. The assigned shallow-dose equivalent must be the dose averaged over the contiguous 10 square centimeters of skin receiving the highest exposure. The deep-dose equivalent, lens dose equivalent, and shallow-dose equivalent may be assessed from surveys or other radiation measurements for the purpose of demonstrating compliance with the occupational dose limits, if the individual monitoring device was not in the region of highest potential exposure, or the results of individual monitoring are</p>

§20.1905 (g)	Exemptions to Labeling Requirements		NRC (***)please note Part 20.1905 (a) – (f) still remains a Compatibility Category A only the newly added paragraph (g) is a Compatibility Category NRC)	<p>In § 20.1905 paragraph (g) is added to read as follows:</p> <p>(g) Containers holding licensed material (other than sealed sources that are either specifically or generally licensed) at a facility licensed under Parts 50 or 52 of this chapter, not including non-power reactors, that are within an area posted under the requirements in § 20.1902 if the containers are:</p> <p>(1) Conspicuously marked (such as by providing a system of color coding of containers) commensurate with the radiological hazard;</p> <p>(2) Accessible only to individuals who have sufficient instruction to minimize radiation exposure while handling or working in the vicinity of the containers; and</p> <p>(3) Subject to plant procedures to ensure they are appropriately labeled, as specified at § 20.1904 before being removed from the posted area.</p>
