Dear Dr. Wang:

Enclosed is Amendment No. 17 to your NRC Material License No. 13-32241-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

This amendment incorporates most of the changes mentioned in your letter dated January 3, 2011. Although you did not explicitly direct us to delete authorization for the lotrex/GliaSite in Subitem Nos. 6. through 9.G., I deleted it anyhow, since you never possessed it and it is no longer manufactured.

I retained authorization for manual brachytherapy permanent implants at the location in Condition No. 10.A. because it was not clear to me whether you wanted it deleted or not. Please clarify this matter in a future amendment request that addresses the remaining issues in your renewal. This issue was also addressed in my letter to you dated November 29, 2011, but your response needs clarification.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.
