We did not receive a copy of the Iowa license for Daniel Trajchel, R.Ph. in your letter dated January 20, 2011.

However, in your letter dated March 21, 2011, Mr. Trajchel was listed as an ANP on the Illinois license enclosed and I also found Mr. Trajchel listed as an ANP on another license for your company in Michigan. So I approved him at this time.

Please be reminded that, in order for us to approve of Authorized Nuclear Pharmacists (ANPs) who are licensed in Agreement States, you must provide a complete, signed and dated copy of the Agreement State license for our review.

Further, whenever you are changing the corporate name of your license in any way, you should address whether a change in ownership or control has occurred. Please refer to Appendix F in NUREG 1556, Vol. 13, Rev. 1 for additional information in this regard.

In order to help ensure that your amendments are prepared properly, please also see Section 9 on page 9-1 in NUREG 1556, Vol. 13, Rev. 1.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's


