Dear Mr. Yantzi:

Please find enclosed Amendment Number 04 to NRC License Number 49-17605-04. **This license amendment updated your inventory and includes the fixed gauges you intend to purchase. Please note, we did not remove the two Thermo Gamma-Metrics Bulk Material Analyzer Model 2000. In order to remove the aforementioned gauges from your inventory, please provide documentation showing when the gauges were decommissioned and removed from your site. In addition, we do not name Alternate Radiation Safety Officers on the license. The RSO may delegate day to day tasks to an individual(s), however the overall radiation program is the sole responsibility of the RSO.** An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(viii). You should review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or if you have any questions, contact me at 817-276-6596.
