Dear Mr. Bialek:

Due to a change in NRC's licensing policies, we must obtain possession limits for all materials listed on your license. As we discussed with Leonard Warbiany by telephone on April 2, 2011, we have listed the total possession limit for byproduct materials in leak test samples as 10 millicuries per leak test sample and 100 millicuries total in Item 8.B. in a corrected copy to Amendment No. 38 to your NRC Material License No. 12-11286-01.

Please note that the possession limit in Item 8.B. must be kept below the minimum limit specified in 10 CFR 30.35 (d) for establishing decommissioning financial assurance as specified in License Condition 15. Also note, we have added License Condition 10.B. which states that you will not take possession of the radioactive materials specified in Item 6.A. while at the client's facility.

As we discussed with Leonard Warbiany by telephone on April 2, 2011, you need to amend your NRC license to name a new Radiation Safety Officer (RSO) as soon as possible, since Joseph Zlotnicki (individual currently named as the RSO) left the company about 2 years ago. We understand that you have replaced the RSO with a qualified individual, however, you still need to amend your NRC license to name the new individual as the RSO as soon as possible. Please see Item 9, "Amendment and Renewal to a License" in NUREG-1556, Volume 18 (copy enclosed), NRC Form 313, "Application for Materials License" (copy enclosed), and Item 8.7.1, information regarding the training and experience for the RSO (copy enclosed).
