Per Section A.4, FAR Clause 52.212-5, Contract Terms and Conditions Required to Implement Statutes or Executive Orders – Commercial Items, paragraph (c)(1) 52.222-41, Service Contract Act of 1965, as Amended, and Section A.16, Determination of Minimum Wages and Fringe Benefits, each employee of the contractor or any subcontractor performing services under this contract shall be paid at least the minimum allowable monetary wage and fringe benefits prescribed under the U.S. Department of Labor Wage Determination. At time of award, the U.S. Department of Labor Wage Determination No. 2005-2103 Revision No. 1 dated 8/22/2006 applied to the contract and was attached.

The purpose of this modification is to update the U.S. Department of Labor Wage Determinations for Option Years Two, Three, and Four under this contract.

Accordingly, the U.S. Department of Labor Wage Determination No. 2005-2103 Revision No. 6 dated 5/29/2008 is incorporated into Option Year Two for the period 12/1/2008 through 11/30/2009.

The U.S. Department of Labor Wage Determination No. 2005-2103 Revision No. 8 dated 5/26/2009 is incorporated into Option Year Three for the period 12/1/2009 through 11/30/2010.

The U.S. Department of Labor Wage Determination No. 2005-2103 Revision No. 10 dated 6/15/2010 is incorporated into Option Year Four for the period 12/1/2010 through 11/30/2011.

The three applicable U.S. Department of Labor Wage Determinations No. 2005-2103 Revision No. 6, Revision No. 8, and Revision No. 10 are attached to this modification.

This modification does not add any additional funding. The obligated amount remains unchanged at \$920,622.00.

The ceiling amount of the contract remains unchanged at \$920,729.14.

The period of performance remains unchanged from December 1, 2006 through November 30, 2011.

All other terms and conditions remain the same.
