SUMMARY

We have reviewed your requesting license amendment request and find that we are unable to continue this action until we have received information regarding the following:

1. The amendment request was silent as to whether PET is being used at this facility. If PET is being used, additional shielding calculations may be required.  
**RESPONSE: Per our discussion, the licensee confirmed that no PET is being used. No further action is required at this time.**
2. Two facility diagrams were submitted, in support of your amendment request. Please resubmit the facility diagrams, indicating scale.  
**RESPONSE: Updated facility diagrams, indicating scale, were submitted and received via facsimile on May 3, 2011. No further information is required at this time.**
3. The amendment request indicated that the existing nuclear medicine spaces are slated for demolition. Please note that, prior to demolition, close-out surveys of the area to be released should be submitted to the NRC. The close-out of the area needs to be approved prior to the release of the area for unrestricted use.  
**RESPONSE: Per our discussion, the licensee confirmed an understanding that a termination request, together with close-out surveys, is required to be submitted to the NRC, prior to demolition. No further action is required at this time.**
