Dear Dr. Morris:

The Wisconsin Public Service Corporation recently placed an order with the Westinghouse Electric Corporation for a 500 MWe pressurized water reactor for commercial operation in 1972. We are tentatively planning to locate the new plant on a site approximately 4 miles north of the location of the Point Beach site being developed by Wisconsin Michigan Power Company on the western shore of Lake Michigan.

The purpose of this letter is to request an early audience with you to briefly outline our tentative plans and scheduling for constructing the nuclear plant. We feel that such a meeting would aid our planning for submittal of the construction permit application. Accompanying us on our visit would be representatives from our architect-engineering firm, Pioneer Service & Engineering Company, and their nuclear consultant, the NUS Corporation.

Please advise me as to a meeting date that would be convenient to you.
