Reference 1 transmitted the NRC's Safety Evaluation Report (SER) "Environmental" Qualification of Safety-Related Electric Equipment" for the Kewaunee Nuclear Power Plant and the supporting Technical Evaluation Report (TER) prepared by your consultant, Franklin Research Center (FRC). Your letter and the SER requested that we review the TER and inform you whether any portions of the identified pages still require proprietary protection.

Therefore, to the best of our knowledge, public release of the FRC TER will not compromise the manufacturers' proprietary claims.

Paragraph 3.4 of the FRC TER states that an "implementation guide (TER-C5257-532) has been prepared and issued to the NRC" which will "enable licensees to understand and resolve, in an expeditious manner, qualification deficiencies identified as a result of this TER." We would appreciate your
