Continued refinement of our Environmental Qualification program has disclosed an error in Reference 1. Six solenoid valves manufactured by ASCO, Plant IDs 33124-33126 and 33130-33132 inclusive, should be deleted from our list of qualified equipment, Table B-1 of Reference 1. These solenoid valves control the operation of our 36-inch containment purge supply and exhaust valves. In Reference 2, we committed to maintain these 36-inch valves sealed shut while above hot shutdown. Consequently, the associated solenoid valves no longer perform a function important to safety and need not be environmentally qualified per 10CFR50.49.
