Reference 1 transmitted, in part, WCAP 11643, Kewaunee Steam Generator Sleeving Report, November, 1987 (Proprietary), and WCAP 11644, Kewaunee Steam Generator Sleeving Report, November, 1987 (Non-Proprietary).

Reference 2 summarized the March 31, 1988 meeting of Wisconsin Public Service, Westinghouse, and US NRC staff to discuss proposed changes to the steam generator tube sleeve installation process variables described in WCAP 11643.

Reference 3 recapped the March 31, 1988 meeting and concluded with the NRC staff finding that the described process variable changes did not affect previous NRC approval, and cited agreement to the operation of Kewaunee with the modified sleeving process.

As a result of successful long-term qualification testing of sleeves installed using the modified process variables, WCAP 11643 and WCAP 11644 have been updated to incorporate these modified process variables. WCAP 11643 Rev. 1 (Proprietary) and WCAP 11644 Rev. 1 (Non-Proprietary) are included as Attachment 1 and Attachment 2, respectively.
