This letter is to inform you of recent organizational changes that took place within the Wisconsin Public Service Corporation (WPSC) organization.

Reference 1 provided notification of WPSC's Vice President-Power Production's promotion to Senior Vice President-Power Production. Reference 2 requested an amendment to Section 6 of the Kewaunee Nuclear Power Plant Technical Specifications and Operating License due to this personnel title change.

Effective July 5, 1989 the Senior Vice President-Power Production will be leaving the WPSC nuclear organization to accept a position with another nuclear utility. A revision to Proposed Technical Specification (TS) Amendment No. 87 (reference 2) will be made within the 60 day time frame required by TS 6.2.3 to reflect the deletion of this personnel title. In addition, the proposed amendment revision will include the following recent title/personnel changes that affect Section 6 of the TS.

Effective July 1, 1989, Mr. Clark R. Steinhardt, Manager-Nuclear Power, has been promoted to Assistant Vice President-Nuclear Power. Mr. Steinhardt assumes responsibility for all nuclear power and quality assurance operations and will report to WPSC's Chief Executive Officer.


