The NRC Staff recently indicated that the incorporation by reference of the DCD references continues to need to be more specific with regard to proprietary and safeguards information in accordance with 10 CFR Part 52, Appendix D, Section IV.A.3, which indicates the applicant must "Include, in the plant-specific DCD, the proprietary information and safeguards information referenced in the AP1000 DCD."

Response:

The FSAR Subsection 1.1 and Part 10 discussions of incorporation of the DCD and DCD references are revised as shown in the Application Revisions section below to include more specific information related to the incorporation of, and access to, the "proprietary information and safeguards information referenced in the AP1000 DCD," i.e., the withheld material in the DCD.

This response is expected to be STANDARD for the S-COLAs.

Associated VEGP COL Application Revisions:

1. COLA Part 2 (Revision 4), FSAR Chapter 1, Section 1.1, Introduction, will be revised from:
