Dear Mr. Spencer:

By letter dated June 10, 2011, you were informed by the U.S. Nuclear Regulatory Commission (NRC) that your site should be reclassified as a Group 5 site in accordance with the criteria outlined in NUREG-1757, "Consolidated Decommissioning Guidance," Volume 1. This determination was a result of NRC review of additional information regarding impacts due to an on-site septic tank found under the foundation of the former production building.

Furthermore, in accordance with the NUREG-1757 guidance, the NRC staff project management responsibilities for your site transferred from NRC Region III to NRC Headquarters Office of Federal and State Materials and Environmental Management Programs (FSME), located in Rockville Maryland.
