Dear Mrs. Ellefson:

Thank you for your letter of June 21, 1973, requesting information on applications which the Atomic Energy Commission has received to construct nuclear power plants in south or central Wisconsin.

The Atomic Energy Commission has not received an application for a construction permit for a nuclear power plant to be built in the State of Wisconsin since August 1967. Since that time, the Commission has licensed the following plants for operation:

1. Dairyland Power Cooperative's LACROSSE Nuclear Plant located south of Genoa, Wisconsin, was licensed to operate in 1967, Provisional Operating License No. DPRA-5 later superseded by DPRA-6 issued October 1969.
2. Wisconsin Electric Power Company and Wisconsin Michigan Power Company's Point Beach Nuclear Plant, Units 1 and 2, located at the Town of Two Creeks, Wisconsin, was licensed (License No. DPR-24 and DPR-27) to operate at full power in May 1973 and March 1973, respectively.

In addition, a Construction Permit CPPR-50, was issued on August 6, 1968, to the Wisconsin Public Service Corporation, for its Kewaunee Nuclear Plant, located at the Town of Carlton, Wisconsin. A notice of hearing

on the Facility Operating License for Kewaunee was published in the Federal Register on October 6, 1972 (37 F.R. 21200). The initial session of the evidentiary hearings convened on February 7, 1973. The hearings have now recessed and are expected to reconvene some time later this year.

By copy of this letter, we are informing our Office of the Secretary of your request to be placed on the mailing list to receive information on hearings on environmental matters for plants located in the State of Wisconsin.
