Gentlemen:

This refers to the routine safety inspection conducted by Messrs. P. I. Castleman and J. S. Stewart of this office during the period from March 11 through April 21, 1990, of activities at Kewaunee Nuclear Power Plant authorized by NRC Operating License No. DPR-43 and to the discussion of our findings with Mr. M. L. Marchi at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

During this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice. A written response is required.

Additionally, during this inspection, certain of your activities appeared to be in violation of NRC requirements as identified in the enclosed copy of our inspection report. The inspection showed that the violation met the test of 10 CFR 2, Appendix C, Section V.G.1; accordingly, no Notice of Violation was issued. No reply to the violation is required, and we have no further questions regarding this matter at this time.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC Public Document Room.
