Description of Occurrence:

The electric generator had been taken off the line and the reactor was critical when a Hi-Hi steam generator level was indicated on 1B steam generator. Main feed water pump 1A tripped off with the Hi-Hi steam generator level. 1B Main feed water pump was off the line due to maintenance and the breaker was tagged open. Upon receipt of the Hi-Hi level Auxiliary Feed Water Pump 1B started, but 1A Auxiliary Feed Water Pump did not start. The switch for 1A Auxiliary Feed Water Pump was put in the START position and the pump started.

The above Abnormal Occurrence was discussed with Dick Knop of Region III at 1015 on October 26, 1974.
