Dear Mr. Comey:

In my letter of August 10, 1972, I advised you concerning the availability of the bulk of the documents which you requested under the Freedom of Information Act regarding the Kewaunee Nuclear Power Station. The purpose of this letter is to address the remaining parts of your request.

1. You requested "(4.) Report or reports of the Division of Reactor Licensing to the ACRS dealing with the proposed Kewaunee Plant."

This material is available to you and comprises approximately 62 pages. The cost of supplying this material is \$6.20 (at a reproduction cost of \$.10 per page).

2. You requested "(5.) All minutes, notes, agendas and/or transcripts of ACRS committee and subcommittee meetings from January 1963 to the present."

As background, the ACRS uses minutes, rather than notes or transcripts, to record the meetings of the Committee and its subcommittees. We have already advised you concerning the determination that the minutes of meetings of the ACRS and of its subcommittees are exempt from disclosure under exemption 5 of the Freedom of Information Act (5 U.S.C. § 552(b)(5) and Section 9.5(a)(5) of the AEC's implementing regulations (10 CFR § 9.5(a)(5)). The ACRS does prepare Committee and subcommittee agendas which are circulated to AEC personnel and we are prepared to make copies of these available to you. The Committee agendas comprise approximately 250 pages and will cost about \$70.00, exclusive of the cost of reproduction, using the formula set forth in attachment D of my letter of August 4. Subcommittee agendas number approximately 220 pages and will cost about \$60.00, exclusive of the cost of reproduction. As background for the above figures, the subject agendas are contained in diverse proceedings files covering the past 10 years, and we estimate that 24 man hours will be needed to compile these documents.


