MEETING SUMMARY

1. Persons Contacted

2. Management Meeting

A meeting was conducted by Messrs. Keppler, Fiorelli, Boyd and Jordan at WPS corporate offices in Green Bay, Wisconsin with Messrs. James, Geisler, Sobel, Luoma and McVicker to discuss the following items:

- a. The current NRC organization and IE:III organization was described. Enforcement and reporting policies were explained.
- b. Licensee representatives described their corporate organization and recent changes in the nuclear support organization reporting to Mr. Geisler. The support organization was described as consisting of three managers with a staff of three persons each. Mr. Stern, Nuclear Licensing and System Supervisor; Mr. D. C. Hence, Nuclear Services Supervisor and Mr. C. I. McVicker, Quality Assurance Supervisor.
- c. The IE:III personnel reviewed enforcement items which have been identified since plant licensing. An apparent communications problem regarding responses to certain of those items was identified. IE:III personnel stated that the licensee's performance based upon numbers and types of items of noncompliance appeared to be improving since initial licensing.
- d. IE:III representatives reviewed abnormal occurrences since fuel loading. IE:III representatives stated that when the licensee was in doubt about reportability aspects of a possible abnormal occurrence the resident inspector is available for discussion of the item. The licensee was reminded of the necessity for timely submittal of reports.

- e. The general conduct of plant operations was stated to be acceptable in all areas. The resident inspector identified the quality and scope of audits by the corporate staff as deserving special comments and compliment.
 - f. The resident inspection program at Kewaunee was discussed.
 - g. The IE:III representatives stated that a management inspection was planned to be conducted later in the year to review the licensees systems of management controls at the plant and at the corporate office.
- 3. A discussion was held by Mr. Jordan with Mr. Stern regarding the responsibilities of the Nuclear Licensing and Systems Group.
 - 4. The IE:III personnel met briefly with Mr. Ziemer, President of WPS at the conclusion of the meeting.
