The NRC issued Bulletin 2011-01, Mitigating Strategies, to achieve the following objectives: 1) to require that addressees provide a comprehensive verification of their compliance with the regulatory requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) Section 50.54(hh)(2); 2) to notify addressees about the NRC staff's need for information associated with licensee mitigating strategies under 10 CFR 50.54(hh)(2) in light of the recent events at Japan's Fukushima Daiichi facility in order to determine if a) additional assessment of program implementation is needed, b) the current inspection program should be enhanced, or c) further regulatory action is warranted; and 3) to require that addressees provide a written response to the NRC in accordance with 10 CFR 50.54(f).

NRC Bulletin 2011-01 requests a 30-day as well as a 60-day response pursuant to the provisions of 10 CFR 50.54(f). The Attachment to this letter provides the requested 30-day response for Nine Mile Point Nuclear Station Unit 1 and Unit 2.
