


This form is a NOTICE OF VIOLATION, which may be subject to posting in accordance with 10 CFR 19.11.</p> <p>SHAW procedure 8822-0006-0151 requires Controlled Areas to be posted with a sign every 60 to 100 feet. Contrary to the above, on March 28, 2011, the licensee had not posted a portion of their Controlled Area along the waterfront, facing the bay at Hunters Point, CA, a temporary jobsite. The licensee corrected this immediately.</p>
