Quality Assurance Group. Additionally, Specification 6.5.3.8 was revised to replace the word "all" with "the" in the phrase "conformance to the provisions contained within the technical specification." This is more consistent with the intent of the specification since an audit does not generally apply to all the provisions in the technical specification. Finally, Specification 6.5.3.8.f was revised to remove the word "annual" which was inappropriate in reference to the 24-month time span requirement in connection with the independent fire protection and loss prevention program. Plant Services Superintendent is the new title for the former Technical Supervisor. The former Technical Supervisor title is assigned to a new position heading a plant technical staff reporting to the Plant Manager.

Since this proposed amendment replaces the previous submittal in its entirety, and based upon our verbal request to withhold any review of our previous letter pending this resubmittal, no fee is enclosed and the \$1200 fee submitted with our September 8 letter is to be applied to this proposed amendment.


