Enclosed please find 40 copies of Proposed Amendment No. 50 to the Kewaunee Plant Technical Specifications. This proposed amendment reflects the reorganization of the Nuclear Department which became effective June 1, 1982. In order to avoid confusion, we have waited until a previous proposed amendment reflecting the reorganization of the Nuclear Department in December, 1980, was approved. That amendment was approved and issued to us in July, 1982. The following pages are affected by this proposed amendment:

In addition to title changes incorporated by this revision, the technical specifications are revised to (1) reflect the organization and authority of the Corporate Nuclear Engineering Staff (CNES), (2) clarify the meeting frequency and line of authority for the Nuclear Safety Review and Audit Committee (NSRAC), (3) show functional responsibilities instead of titles in the Power Supply and Engineering Department and Kewaunee Nuclear Power Plant, and (4) correct two minor typographical errors.

TS 6-2a is changed to add the specification number 6.4 to the Training section. It was apparently omitted in a previous amendment.

TS 6-5 reflects the title changes of the Manager - Nuclear Power to Vice President - Nuclear Power and the Assistant Manager - Nuclear Power to Manager - Nuclear Power.

TS 6-6 is amended to reflect the current make-up of the CNES.

TS 6-7 has been altered regarding Section 6.5.2.4 Authority of the CNES. This section has been updated to reflect functional groups in the Power Supply and Engineering Department and the current organization of the Nuclear Department.

TS 6-8 and TS 6-11 have been updated to reflect the line of authority from the Vice President - Nuclear Power to the NSRAC. Section 6.5.3.5 was reworded to clarify the NSRAC meeting frequency, reflecting the current operation of the plant.

TS 6-12 reflects the title change of the Assistant Manager - Nuclear Power to Manager - Nuclear Power.

TS 6-17 was corrected for a typographical error. The second word under item (5) is changed from of to or.


TS 6-26 and TS 6-27 (Figures) were changed to show functional responsibilities instead of job titles. This relieves some of the burden from the Nuclear Department to request a Technical Specification amendment each time an individual's title changes. The charts were moved to the Figures section.

TS 6-28 was renumbered as TS 6-26, occupying the space vacated by the organizational charts moving to the Figures section.

TS 6-27 and TS 6-28 were subsequently deleted.

We have determined these changes are CLASS II, administrative in nature. A check in the amount of \$1,200.00 is enclosed in accordance with 10 CFR 170.22 requirements.


