Enclosed please find three (3) signed and notarized original transmittal letters and forty (40) copies of Proposed Amendment No. 55a to the Kewaunee Nuclear Power Plant Technical Specifications. This revision of Proposed Amendment No. 55 (Reference 3) is being submitted at the request of the staff to resolve the issue of the definition and application of the term "Operable". The definition of the term (TS 1.0.e) has been revised consistent with the clarification and Model Technical Specifications provided by the NRC in Reference 4. A clarifying statement has been added to the definition which explicitly addresses support equipment and electrical power supplies. Reference 2 provided additional information on this issue in response to the Technical Evaluation Report transmitted by Reference 1. Minor wording changes have also been made to TS 3.3.a.1.A and TS 3.3.a.1.B in order to clarify the volume of water to be contained in each accumulator and when the accumulator isolation valves should be opened with their power breakers locked out.
